Additionally, a second Trump administration would take the extreme position that the **Constitution entitles employers to discriminate against LGBTQ people based on their religious beliefs**, *notwithstanding state nondiscrimination laws*. And, shockingly, it would try to *erase transgender people from public life entirely* by using federal obscenity laws to criminalize gender nonconformity.

Trump thrives on the fear, chaos, intimidation and by flexing his Authoritarian arm he drives fear of retribution into our Democracy. This is not the American way of life.
